SUBJECT: **PRE-QUALIFICATION OF CONSTRUCTORS**

Shaheed Mohtarma Benazir Bhutto Chair, University of Karachi intends to Pre-qualify constructors/firms for the construction of office, Convention Center, and allied Facilities at University of Karachi Campus.

Brief scope of work: The work comprises of construction of Convention center for 2000 persons, an office building (G+1) on an area of 16,000 sft and allied facilities including complete electrical, Plumbing, HVAC, Telecommunication and other related works.

ELIGIBLEITY CRETERIA

1. Firms having valid PEC Registration Certificate in Category C-2 and above together with specialization Codes. CE-01, CE-09, CE-10, EE-03, EE-04, EE-06, ME-01, ME-02 & ME-03, valid for the year 2014-2015.
 2. Interested constructors / Firms must be able to demonstrate proof of experience of Building Works of similar nature and complexity.
- **Documents Required:-**
 - Name of constructors / Firm, its status, address, telephone number (s), Fax number, years of experience of the constructors / firm with proof.
 - Experience of overall and similar works over the last five years with copies of Letter of Acceptance and Completion Certificates. (Performance certificates of assignments / projects completed are to be attached), along with contact details of the client.
 - Existing work load with details of work under execution.
 - List of machinery and equipments required to be used on the project.
 - Details of work experience in the region (Karachi – Sindh).
 - Registration for Prequalification with different Organizations along with documentary evidence
 - Financial Soundness Certificate, Bank Statement for the last 5 years.
 - Annual turnover for last 5 years & details of available bank credit line with the constructor.
 - Affidavit on stamp paper to the effect that the constructors / Firm is not blacklisted and is not in litigation with any organization / department, private or public.
 - Any other relevant information which the constructors / Firm intends to submit for its prequalification.
 - Eligible constructors/firms may obtain “PREQUALIFICATION DOCUMENTS” from the Office of the Project Director, Shaheed Mohtarma Benazir Bhutto Chair on payment of Rs. 1,000/= (Non-refundable) in the form of Pay Order in favor of Shaheed Mohtarma Benazir Bhutto Chair, University of Karachi.
 - Applicants should submit Prequalification Documents duly completed in all respect along with all the supporting documents by 1600 hours, **December 15, 2014** by strictly following the instructions contained in the document. Incomplete Prequalification applications shall be treated as non-responsive and shall be rejected.
 - The client reserves the right in its sole discretion to reject any or all prequalification documents as per provisions of SPPRA /PEC Rules.
