## **OBSERVATIONS:**

- M/S. Asghar Ali & Co. are the 1<sup>st</sup> lowest tenderer. Their bid amount has increased from Rs. 13,079,892.59 to Rs. 13,458,709.08 (difference: Rs. +378,816.49) due to calculations errors but their position has not changed after scrutiny. They are approximately 3.52% lower than 2<sup>nd</sup> bidder.
- M/S. Iqbal Progressive Builders are the 2<sup>nd</sup> lowest tender. Their bid amount has decreased from Rs. 13,961,605.00 to Rs. 13,950,354.66 (difference: Rs. -11,250.34) due to calculations errors but their position has not changed. They are approximately 1.68% lower than 3<sup>rd</sup> bidder. Over writing and cuttings in quoted rate have been observed on Page # 21 and Summary.
- M/S. Paramount Construction are the 3<sup>rd</sup> lowest tenderer. Their bid amount has decreased from Rs. 14,188,500.00 to Rs. 14,188,284.63 (difference Rs. -215.37) due to calculations errors but their position has not changed after scrutiny. They are approximately 5.41% lower than 4<sup>th</sup> bidder.
- 4. M/S. Pentagrams Enterprises are the 4<sup>th</sup> lowest tenderer. Their bid amount has not changed and also their position after scrutiny. They are approximately 0.26% lower than 5<sup>th</sup> bidder.
- M/S. Modern Dynamic Associates are the 5<sup>th</sup> lowest tenderer. Their bid amount has not changed and also their position after scrutiny. They are approximately 5.84% lower than 6<sup>th</sup> bidder.
- M/S. Ahmed Hussain Jagirani are the 6<sup>th</sup> lowest tenderer. Their bid amount has not changed and also their position after scrutiny. They are approximately 2.00% lower than 7<sup>th</sup> bidder. Over writing and cuttings in quoted rate have been observed on Summary Page.

- 7. M/S. Pak Arabian Construction are the 7<sup>th</sup> lowest tenderer. Their bid amount has increased from Rs. 16,137,011.00 to Rs. 16,298,438.55 (difference Rs. +161,427.55) due to calculations errors but their position has not changed. They are approximately 2.39% lower than 8<sup>th</sup> bidder. Over writing and cuttings in quoted rate have been observed on Page # 21 and Summary.
- M/S. Precise Construction are the 8<sup>th</sup> lowest tenderer. Their bid amount has increased from Rs. 16,466,678.00 to Rs. 16,697,393.51 (difference Rs.+ 230,715.51) due to calculations errors but their position has not changed. They are approximately 6.14% lower than 9<sup>th</sup> bidder.
- 9. M/S. Nasim & Co (Pvt.) Ltd are the 9<sup>th</sup> lowest tenderer. Their bid amount has increased from Rs. 17,790,569.00 to Rs. 17,790,569.27 (difference Rs. +0.27) due to calculations errors but their position has not changed. Over writings and cuttings in quoted rate have been observed on Summary Page.

## **RECOMMENDATION:**

The tender of 1<sup>st</sup> lowest Contractor M/S. Asghar Ali & Co. has been further examined and it has been observed that the rates quoted by them are reasonable and workable. Their rates are 10.27% below the Estimated Cost. It is therefore, recommended that the work may awarded to them.
